First of all I would like to say that I am very honored to serve you as your State President. I look forward to an exciting and challenging year of service.

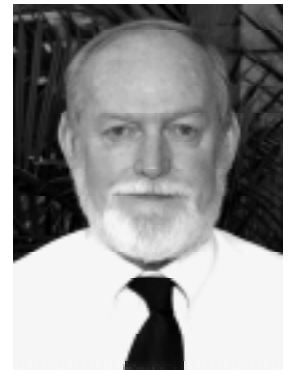

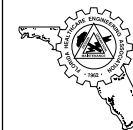

Dear David:

This letter is to express my sincere appreciation and gratitude for the kindness and generosity of the Florida Healthcare Engineering Association on my behalf. I am overwhelmed and humbled by your kind and caring gesture. I will apply the \$1000.00 you sent toward the replacement of some of the tools and equipment I lost at my home due to the flood.

The following information is provided to bring you up to date on recovery efforts both at the hospital and my home:

Hospital: The hospital received approximately 3-1/2 feet of water throughout the first floor (approximately 80,000 SF) which of course housed everything of significant value and generated revenue. With a lot of help from our vendors, an outside contractor and hard work by our staff, including the nurses and clinical support staff (they did all of the painting), we were able to reopen our Emergency Department on the 5th of October; 25 patient care beds on the second floor on the 28th of October; Surgical Services to include two operating rooms and all support elements on the 27th of December; and OB will open on Monday 9 January with four LDR's to get us started with dealing with the impending population explosion also credited to Hurricane Katrina.

We have also replaced two x-ray rooms, nuclear med equipment, and our new CT scanner is due to arrive on Monday, 9 January.

Home: I haven't had much time to focus on it due to the items mentioned above. My wife and I purchased a comfortable 5th wheel camper that we are living in temporarily. We are living behind the hospital as our neighborhood is still in pretty rough shape in Pass Christian. Our home is repairable as it received approximately 18 inches of water in the first floor. I should mention however, that it is constructed on cement block columns and the first floor elevation is 23 feet above sea level, to give some perspective on the amount of water we received. Just enough to ruin appliances, furniture, etc. on the first floor of the house and of course anything stored under the house was submerged. This included a 1969 Camaro, a boat, a golf cart, a riding lawn mower and lots of wood working tools that unfortunately the flood insurance does not cover. I am making some progress on getting the house cleaned out and preparing it for re-assembly. Hopefully by the end of the summer we will be able to get back in the house.

I want to again express my appreciation for you and your association's kindness. If I can be of assistance in any way possible, please let me know. I am willing to share our experience with anyone interested, hoping that it might assist in updating preparedness plans and preparations.
